

**Meghalaya Start-up for Trainers
M-STARTT
under Skill Meghalaya**

A. INTRODUCTION

NSDC under the aegis of Ministry of Skill Development & Entrepreneurship is implementing training program for the professional development of “Skill Trainers” in the short-term skill eco-system through Sector Skill Councils (SSCs). In order to create a pool of certified trainers in the State, MSSDS under the project M-STARTT, intends to fund 120 residents of Meghalaya for training of trainers through the SSCs so as to enable them to start their own Training Centres or be part of an existing Training Partner in their respective Districts.

The primary objective of the M-STARTT is to introduce the trainers to the changing space of training. Training of Trainers through SSCs is a program for the development of training delivery skills of those who wish to become trainers in the sector of their preference and aligns them with the National Skill Qualification Framework (NSQF).

In order to support the certified trainers under M-STARTT, Training Centres (existing / new) will be empanelled with MSSDS under Skill Meghalaya and allotted training targets as per norms.

MSSDS will also provide a one-time grant-in-aid of INR.5.0 Lakhs (Rupees Five Lakhs) each against CAPEX to the Top 30 performers (six per job role, 2 from each region) for setting-up a Training Centre or introduce the job role in an existing training centre they are associated with.

The following will be the break-up of regions for selection of the Top 30:

1. Region 1: Khasi Hills Districts
2. Region 2: Jaintia Hills Districts and Ri Bhoi District
3. Region 3: Garo Hills Districts.

B. JOB ROLES

The following Job Roles have been identified:

1. Fashion Designer – QP AMH/Q1201
2. Cosmetologist - QP BWS_Q0107
3. Mason Tiling – QP CON/Q0104
4. Doors & Windows Fixer – QP CON/Q1105
5. Construction Painter & Decorator – QP CON/Q0503

C. TRAINING LOCATION

Trainings for each job role will be conducted in two locations – Shillong for Khasi-Jaintia & Ri Bhoi Region and Tura for Garo Region

D. SELECTION OF CANDIDATES

2 (Two) candidates per job role per district as recommended by the District Skill Development Committee will be selected for the programme. Candidates will need to meet the eligibility criteria indicated at Para E.

E. ELIGIBILITY CRITERIA:

1. Candidates must be permanent residents of Meghalaya
2. Candidates must meet the eligibility criteria prescribed for the specific job role indicated at Para G.
3. Candidates must either be a trainer in an existing Training Organization or willing to set-up a Training Centre for the Job Role in the respective District.
4. Candidates must be willing be registered as an Enterprise under Udhyan through District Commerce and Industries Centre or as a Society under the Societies Registration Act, 1860.

F. HOW TO APPLY

G. JOB ROLES

The following job roles have been tentatively chosen. Based on the applications received, MSSDS may change or introduce other job roles.

Job Role 1: Fashion Designer

Remarks	Specialization in Beauty, Makeup & Hair. Diploma should be minimum of 6 months period.
