

**Proceedings of the 1<sup>st</sup> meeting of the Executive Council of the  
Meghalaya State Employment Promotion Council on the 25<sup>th</sup> October,  
2011 at 11:00 AM in the office chamber of the Chief Secretary &

The meeting was chaired by Shri.W.M.S.Pariat, Chief Secretary Cum-Chairman, MSEPC who welcomed all the members of the 1<sup>st</sup> meeting of the Executive Council, MSEPC.

Thereafter, the CEO, MSEPC briefed the members about the purpose of the meeting i.e. the need to launch placement linked skill development programmes in different trades by enhancing the productivity of the new entrants to the labour force especially the youth in the age group of 18-35 through various agencies.

After a threadbare discussion on the Agenda, the following decisions have been taken: -

1. The Mission Document for skill development in the state should be made ready as soon as possible.
2. The Meghalaya State Skills Development Society should be registered at the earliest, as already provided for under the mandate of the MSEPC.
3. The target to organize placement linked skill development training programmes for providing employment to one lakh youth in the next 5(five) years would be looked into closely once the society is formed.
4. Addl.C.S. I/C Labour Deptt. Will convene a meeting of the various Head of Departments etc, to discuss on the convergence of capacity building initiatives in different road map for the same.
5. The Committee approved the establishment of a Programme Management Unit under the Society consisting of a Consultant, 2(two) Programme Managers, 2(two) Data Entry Operators, 1(one) MIS specialist and 2(two) Grade IV on contractual basis.
6. The Committee authorized the Chairman to decide on matter relating to recruitment and procurement, as and when they arise.
7. Two workshops on “Current and Emerging employment Opportunities for the youth of Meghalaya” will be held at Shillong and Tura in the first quarter of the next year.
8. The delegation of Financial powers to the Chairman, Executive Council will be taken up after the registration of the Society.

The meeting ended with a vote of thanks from the Chair.
